Jantar Mantar, New Delhi  
Organized by All India Bank Pensioners & Retirees

Kindly refer to our earlier Circular No. 19/13 dated 10<sup>th</sup> July, 2013 wherein a clarion call has been given by AIBPARC to join the Dharna in huge numbers along with spouses and family members (if possible) to demonstrate the anguish, dismay and agony of the Bank Retirees in respect of the long-pending demands which include, inter alia -

1. Pension updation/Revision,
2. Improvement of family Pension in line with RBI employees,
3. 100% DA-neutralisation to pre-01.11.2002 Retirees,
4. Eligibility to full pension after 20 years of service,
5. Option for pension to left-over category who exited after putting pensionable years of service,
6. Comprehensive and uniform medical/hospitalization benefits,
7. Meaningful negotiation - tiers for the Retirees,
8. Miscellaneous.

Comrades, the working employee/officer of today is a pensioner of tomorrow. He/she will be definitely benefited by demands like updation of pension and improvement of family pension. We seek whole-hearted cooperation of all the trade unions of working employees and officers. We have requested all such General Secretaries to remain present in the Dharna and address the gathering. Comrade, Harvinder Singh, General Secretary is also cooperating with us in all possible manner. The Dharna will also be addressed by central trade union leaders, eminent parliamentarians and political leaders of different parties. All of you will definitely appreciate that this is the right and proper time to press the demands with full strength and it is our firm belief that members/activists/leaders/veterans will not lag behind to discharge their duties at a historical moment.

Comrades, immediately on receipt of the circular, please keep us informed about the number of participants which each affiliate has been able to mobilize so far.
