# Regarding Updation of Pension for Bank Pensioners.

We are immensely Grateful to Your Good Self and other Hon'ble Members of Parliament for giving an opportunity to Retirees Organisations to present their petitions to Your Good Self and Members of the Committee in respect of Updation of Pension. We once again would like to briefly submit our case for your kind consideration.

- **1**. Bank Pensioners' Basic Pension remains unrevised though the Pension Regulations were framed in the year 1995 itself.
- **2.** Pension Regulation 35 (1) clearly provides for Updation.
- **3** . In the Year 2003 the said Regulation was further amended to make open ended to ensure Pension Updation along with every Wage Revision.
- **4**. Regulation 56 further states that any doubt in regard to implementation of Pension Scheme in Banks reference should be made to the corresponding Provisions in Central Government Pension Scheme .
- **5**. Moreover Supreme court held that Wage Revision and Pension Revision are inseparable.
- **6.** Banks Pension Scheme is on the lines of Government and RBI Pensioners Scheme.
- **7.** Pension in Banks is given as Second Benifit only as available to Government and RBI Pensioners.
- **8**. Pension Fund is created out of the surrender of management part of PF Contributions by the Pensioners during their service.

are getting 100 Percent DA Neutralization.
