**DEARNESS RELIEF PAYABLE TO INDIAN OVERSEAS BANK STAFF PENSIONERS
FOR THE PERIOD - FEBRUARY 2026 TO JULY 2026**

Indian Banks' Association vide their circular Nos.CIR/HR&IR/76/D/2025-26/2911 & CIR/HR&IR/76/D/2025-26/2913 dated 06.02.2026, revised the Dearness Relief payable to Bank Pensioners/Family Pensioners in terms of Regulation 37 of Bank [Employees'] Pension Regulations 1995, as below.

For EX-GRATIA PENSIONERS - Surviving pre 01.01.1986 retirees of the Bank, from February 2026 to July 2026, the amount payable is $(350+5351.30) = \text{Rs.}5701.30$ and Surviving spouses of pre 01.01.1986 retirees, the amount payable is $(175+2675.65) = \text{Rs.}2850.65$.

However, as per IBA Circular HR&IR/MBR/743/2022-23/11722 dated 07.02.2023, had advised to consider additional ex-gratia payment over and above the amount being paid as per DFS guidelines so as to ensure that the surviving pre 1986 retired employee / surviving spouse of pre 1986 retired employee get a minimum of Rs.10000/- per month as Ex-gratia.
